Query No. 1:

Warranty of 24 months is required in Section VI, art. 2 of the purchase contract. The subject matter of the contract are parts and consumables, that gets worn out by extreme temperatures and pressures. Changing of some materials (fuses, caps) is necessary after some number of mineralization. According to our experience no produces of the microwave digestion instruments provides warranty to decomposition vessels. Exception is company Berghof, that provides warranty of 12 month to decomposition vessels. Will the Contracting Authority accept following article in this wording?

Given that the subject matter has not character of na instrument, but it is a material and parts, in addition in a greater number of pieces (eight complete vessels) when any defect is not expected at the same time by all the vessels, will the contracting authority accept in the relevant paragraph of the purchase contract the replacement phrase "24 hours" by the works "five working days"?

Response to query No. 2:

We accept replacement of the phrase "24 hours" by the words "five working days". New wording of contract is annex of this additional information.
